Q: Can the dying tree behind the entry sign be removed?

A: Yes, we can start getting bids for this

Q: What is happening with the speed bumps that the city originally told us that we could put in?

A: The city did agree to follow through with additional stop signs at one point, I am not sure what the case is now. We will have to check back in with the City and see if we can get the ball rolling on this again.

Q: There is a home on Star Spangled that is looking very mangled and unkept, does the HOA address this?

A: This is a rental property that we have been in contact with multiple times, we will look into additional solutions to try to get through to them.

#### **H) Original Resolutions & New Business**

Q: Do we plan to add some color to the sign area? Maybe a new tree.

A: We can get some bids then during the spring meeting review and see what people would like to do.

Q: There are sections of sidewalk where the roots are coming up and pushing up the side walk. What should we do about this?

A: The City has been working on a sidewalk program throughout the city, not sure they have reached this neighborhood yet, so I would report it to them so it is on their radar.

Q: Can an update be given on how the ACC is doing this year? How are standard approvals going?

The main thing that we haven't really messed with, is basic landscaping like planting a tree. We just ask that improvements go through approval so we have documentation incase it is needed down the road.

Q: There has been a lot of theft in the neighborhood recently, could we form some sort of neighborhood watch?

A: I recommend that you reach out to your Alder person, and the police station for their assistant with this. I would also recommend the NextDoor app for the neighborhood, so everyone can stay on top of things going on.
