G) Unfinished Business

Eco-Park:

A representative from the Land Department at Veridian Homes will be meeting with a representative from the Village of McFarland next week to discuss the next steps needed to convey the Eco-Park to the Village.

Q: What is the term of a Board member? A: One year.

Q: What is the time commitment to being on the Board?

A: It really depends on how involved you would like to be, and how often the Board decided to meet. Could be monthly, quarterly etc. just depends on what the Board would like to do moving forward.

Q: When does conveyance occur?

A: Veridian will convey the neighborhood, we do not know their timeline for conveyance. It will depend upon completion of the next step items, obtaining a contract etc.

Q: Does the contract end with DSI upon conveyance?

A: It will be up to the Board if they would like to continue the contract through the end of the year; we are happy to stay on and help, as everyone gets their feet wet in their new roles.

Q: Is the budget for 2022 set?

A: Yes, the Board will be in charge of completing the budget for the next year.

Q: Can the pet waste survey be sent out again?

A: Yes! Based on the results of the survey that was sent out last year, homeowners were not open to the installation of pet waste stations, due to the additional cost. The Board can re-evaluate this once they take over as well.

Q: What are the consequences for Veridian if they do not complete the requirements to turn the EcoPark over?

A: This is not an option; it must be done as the HOA will no longer be maintaining it.

Q: Where was aeration done?

A: Aeration was done to Frost Aster Court

Q: Can we get dated/itemized receipts from services completed?

A: Shandar to send along to those who request it, via email.

A: Shandar to reach out to Veridian for details.
