B) Proof of Notice of the Meeting

- a. Shandar presented the original letter that was mailed to all homeowners
 - Letter was mailed out on January 19th, 2024
 - Agenda, PowerPoint Slides, Budget and Financials also sent via email the morning of the meeting.

C) Reading of Minutes of the Last Meeting

a. 2023 Minutes were posted on the DSI website: www.dsirealestate.com, owners were asked to read them prior to the meeting. This was done and the minutes were approved.

D) Officers Reports

- a. Collection of Association Dues for 2024:
 - There are currently 45 homes that have yet to pay the 2024 assessment. Of those 44, there are 4 outstanding from 2023.
 - If you are unsure if your dues are paid, please reach out to hoa@dsirealestate.com to verify.
 - Late Fees will be assessed on March 1st. At that time, we will send out late letters to all past due owners and request payment immediately.
 If payment is not made by May, we will move forward with the lien filing process.
 - Once a lien is filed, the dues will need to be paid prior to any sale or refinance.

- b. Snow Removal Responsibilities

A neighborhood snow removal map is posted to the 1000 Oaks Page on the DSI site. The HOA is not responsible for snow removal on the City Streets or Alleys within the 1000 Oaks neighborhood, the City of Madison is. c. Trash Removal

All owners essentially pay twice for trash removal; once the City and once to the HOA; this is how the CCR's were written. Homes on alleyways cannot be expected to bring their trash receptacles through the snow/their yard to the front of the home for pick-up. The City of Madison will also not pick up on the alleys, so we have it contracted through Pelliterri.

J) New Business

Q: Why is 1000 Oaks West not on their own HOA?

A: This was a decision that was made by the Developer.

Q: Why is it that every year we get more houses added on to our HOA yet the HOA fee increases every year. Is the increase coming from 1000 Oaks West as they have added many houses with alleys?

A: Throughout the development of 1000 Oaks, the number of lots paying dues each year has only significantly changed once - When they expanded the neighborhood to include 1000 Oaks West. Annual dues on all vacant lots in the neighborhood are being paid by the developer.

Q: Last season, we had way less snowfall. Does the snow removal fee decrease? Do we get only charged when they come by?

A: Between Jan, Feb and March 23, we had 22 Snow Clearing events, and 27 Salting Events.

Q: Why is it that HOA can't charge houses with alleys more so they pay for their garbage/recycle instead of relying on the hundreds of others to pay for them?

A: This was a decision made by the Developer and the City when the neighborhood was built.

Q: Who controls the HOA and when is it going to the owners of properties of 1000 Oaks?

A: Currently the Developer is in charge, it will be conveyed to homeowners once all homes are sold.

Q: Can you discuss the maintenance plan for the "eyebrow" on Tawny Acorn? Specifically weed control and removal of dead trees?

A: Weedman will be doing all weed control on the common areas in 2024. Veridian has been made aware of the condition of the large (potentially dead) oak tree in the "eyebrow" and they will be taking care of it.

Q: Is it possible to have 1-way signs installed within the median of the "eyebrow"?

A: Please contact the City of Madison Streets Department as this is not something the HOA can assist with.

Q: Can the neighborhood contract with a private company for street snow removal? A: No, the City does not allow this.

Q: Can the city trash bins at the 1000 Oaks park (only there in the summer) be replaced by permanent dog waste stations?

A: Please contact the City Parks Department. We have asked if they would allow us to take over trash collection so we can add nicer cans, and pet waste receptacles and that is not something they will allow.
